# **CCGISC Digital Data Policy - Quick Reference**

The CCGISC Digital Data Policy defines and outlines the terms, conditions, and procedures related to the distribution and use of CCIGSC digital data as approved by the CCGISC Policy Committee. An overview of the Policy is provided below. Please reference the complete CCGISC Digital Data Policy for additional details.

# **DIGITAL DATA CATEGORIES**

# **Custodial Data**

Data CCGISC creates, maintains, and distributes.

# **Repository Data**

Data CCGISC distributes that is created and maintained by external sources - ex. Census Data.

#### **Production Data**

Data CCGISC creates and maintains but does not directly distribute.

#### **Hosted Data**

Data CCGISC hosts on its servers per a contractual agreement.

# DATA DISTRIBUTION TO MEMBERS, MEMBER CONSULTANTS & MEMBER AGENTS

- Custodial and Repository data are made available to CCGISC members at no cost.
- Custodial data are made available to CCGISC
   Member Agents at no cost per the Rules of
   Engagement <u>Appendix L of the CCGISC</u>
   <u>Digital Data Policy</u>. Data can **ONLY** be supplied
   by CCGISC staff.
- Custodial and Repository data are made available to member agency consultants upon execution of the <u>Digital Data Release</u> <u>Agreement</u>. Data can **ONLY** be supplied by CCGISC staff.

## **DATA DISTRIBUTION TO NON-MEMBERS**

 Custodial data may be made available to nonmembers at a cost upon the execution of the <u>Digital Data License Agreement</u>. Data can
ONLY be supplied by CCGISC staff.

# FREEDOM OF INFORMATION REQUESTS (FOIA)

- All FOIA requests for Custodial or Production data shall be addressed in accordance with the <u>Champaign County State's Attorney</u> <u>Opinion</u>.
- All FOIA requests for Repository or Hosted data shall be referred to the originating agency or the agency that retains ownership, respectively.
- FOIA requests for Custodial data made to a member agency shall be referred to CCGISC.

# **DIGITAL DATA RESTRICTIONS**

- Custodial data may be made available online by member agencies and/or Member Agents via websites, apps, etc. for the purpose of viewing and printing ONLY; the data cannot be made available for download or consumption outside of the member agency organization.
- Member agencies and/or Member Agents may NOT publish ANY data directly from the CCGISC servers in a manner which would allow the service to be consumed outside of the member organization.
- Members and/or Member Agents must follow the digital data access and distribution requirements of <u>Appendix L of the CCGISC</u> <u>Digital Data Policy</u>.
